How much Reset CLO₂ do I need?

The product works as it dries, so surfaces and atmosphere's only need to be lightly wetted for it to be effective.

Do I need personal protection equipment? PPE is not required when using (M) level liquid.

Instructions:

Fill desired & corresponding container with tap water. Drop the appropriate RESET Tablet into the water to generate your desired concentration. Put cap on container. Dilute or strengthen solution per product instructions.

Wait 3 minutes for the product to mix and generate properly.

Preparation: Always clean-off any visible dirt & organic matter before treating the desired surface or material.

Application: Apply directly to the atmosphere, surface or material requiring treatment.

Apply Reset CLO₂ with a mop, sponge, sprayer or cold fogger. DO NOT WIPE. LET DRY. DO NOT RINSE.

Generate a CLO₂ Gas Vapor

1) Preparation

Create &/or seal treatment area so that it is a 'confined space' without direct sunlight. i.e. close windows/doors/shades etc. Disconnect confined space' smoke alarms for treatment period. Put Warning/Do Not Enter signs on doors to 'confined space'.

Determine size of space to be treated & severity of issues. Odor types
and environments vary significantly & must be evaluated on a case
by case basis. Select proper Reset product size for intended usage.
 Remove all visible odor sources.

– Then remove all people, plants and pets from the 'confined space' during treatment period. All contents (clothing, upholsteries, rugs etc.) should be dry (not wet) before performing any vapor application, or fading can occur. Place Reset CLO2 and its container in center of space and If possible, with the HVAC return fan 'on' for the entire vapor treatment period.

Use Standard Deodorization Level to reset to neutral any environment and its contents from wide-spectrum pungent and resistant odors.

Use Mold Removal Level to remove difficult mold and extreme environment type issues. We do not recommend using Mold Level for content odor removal, as fading can occur.

2) Vapor Product Activation & Treatment:

Note: Vapor concentrate will stain if spilled.

Warning: Never put your nose directly over the vapor-container while handling. Always wear appropriate NIOSH respirator, goggles and gloves. See product label First Aid section or its SDS.

Vapor Application Treatment Time: 1 hour minimum. 12 to 24 hours is best. Use multiple tablets, paks, buckets and containers for large fragmented spaces.

A) Select appropriate size Reset product and generation container.

B) Add appropriate amount of water to the container. Then add a simple fish tank type aerator to the side of the container, insert its tube and stone into the CLO2 solution and turn it on.

C) Add Reset Tablets/Paks to the container and immediately evacuate the room.

Black 500g Pak: Add 2 gallons of tap water to a clean 5 gallon bucket. Pour Reset Part B into the bucket & water. Stir and mix well. Add & turn on the aerator. Add Part A to bucket and immediately evacuate the confined space.

Purple 200g Pak: Use a 3.5 to 5 gallon bucket, add 1/2 gallon of cold tap water. Add & turn on the aerator. Add the Tablets to the water and immediately evacuate the confined space.

Red 20g Tablets: Add 5oz water to a 24 oz to 32 oz disposable plastic cup. Add & turn on the aerator. Add the 20G Tablet to the water and immediately evacuate the confined space.

Combine 1g, 4g, 20g and 100g Tablets to the desired ClO₂ GRAM requirement. i.e. (25) 20g's = 500 grams and use the corresponding Reset Black, Purple or Red Pak activation protocol. Let the ClO₂ Tablets & Paks generate for 3 minutes. Tablets & Paks will pop/crackle/fizz. Vapor will then begin to disperse. If there is too much foam buildup, add cold water to break it up.

FOR BEST RESULTS use a small (fish tank type) or Reset aerator to agitate the concentrate when using the Red, Purple and Black products.

3) Always air-out the 'confined space' before re-entering and reoccupying. If you smell a 'chlorine' smell, continue to air-out space.

4) Safely dispose the remaining CLO₂ down toilet/drain.

- Re-fill water storage tank with water to approximately 20% of tank capacity. (For example a 55-gallon tank should be filled with 10 gallons of water)
- 3) Add appropriate color and number of Reset CLO₂ Tablets, Fluid solution (or Vapor concentrate) into the water storage tank. In the above 55 Gallon tank example, use 1 Red Tablet.
